- This exhibition focuses on Fiber Arts in general which comes in a variety of forms or expressions. Therefore, the composition of your art work can have a minimal weaving presence of your chosen medium.
- Art pieces must be presented in a frame fashion, ready to be hung
- Multi fibers, old woven samples, new weaves, beads, glass, metal, paper, pet's hair, may be sewn, felted, patched, patterned, beaded, painted, or simply woven
- The minimum width frame size is 20 inches due to the size of the gallery walls. No restriction for height.

Online registration must be completed by **January 2**.

Walk-in deliveries must be “ready to install” and delivered at the Pauahi Mezzanine Gallery, 1003 Bishop St., Honolulu, HI 96813 on Saturday **January 4, 2020, 9 am - 11 am**.

Mailed entries must be “ready to install” and received by **January 3**.

Mail to: G. Chock, P.O. Box 894240, Mililani, HI 96789, packed in reusable packing. The artist is responsible for the shipping costs and insurance to Oahu. The Hui will be responsible for the return cost.

## ENTRY FEE

- First two (2) entries is \$30 for Hui members, \$50 for non-members, and \$20 for students.
- Each additional entry is \$10
- Payment can be made on line via our Website, or by check payable to Hawai'i Handweavers' Hui, P.O. Box 11808, Honolulu, HI 96828

## COMMISSION FEES

- Members: 10% of sale price to HHH if entry is sold during the exhibit
- Non-members: 30% of sale price to HHH if entry is sold.

## RETURN OF ENTRIES NOT SELECTED

Artists will be notified by phone/e-mail of works not accepted. Entries must be picked up on **Saturday, January 4, between 2 pm and 4 pm** at Pauahi Gallery.

The Hui will charge \$25/day storage fee for any work not picked up on time. Shipped work will be returned in original container.

## END OF EXHIBITION, RETURN OF SOLD AND UNSOLD ARTWORK

All entries, whether sold or not, must be picked up by purchaser or artist at the Pauahi Mezzanine Gallery on **Saturday July 11, 9 am—11 am**

The Hui will charge \$25/day storage fee for any work not picked up on time. Shipped work will be returned in original container.

## CONSENT

Submitting a signed entry form constitutes agreement on the part of the artist to all listed conditions including agreement that the entry will be available for the duration of the exhibition. The artist agrees that the Hawai'i Handweavers' Hui may photograph the entry, or reproduce, or edit submitted images for educational or promotional purposes.

## LIABILITIES

Artists understand and agree that they submit all entries for the exhibition at their own risk. All entries will be handled with the utmost care; however neither the Hawai'i Handweavers' Hui, nor Douglas Emmett, Bishop Square will assume responsibility for loss or damage to artworks submitted regardless of amount of damage or how damage might be sustained.
